

Declaration of consent according to EU Data Protection Regulation (GDPR)

Collection and processing of data by wibas GmbH

Our company takes the protection of customer data seriously and wants every customer to feel comfortable when attending our events. The protection of privacy in the processing of personal data is an important concern for us, which we take into account with high attention in our business processes.

For our services, the following personal data is collected and processed:

- Name, first name

The processing of the personal data provided by you is necessary for the proper execution of the underlying contractual relationship (execution of the event, transmission to certification bodies – if required depending on the type of event, documentation of the event) and insofar as we are legally obliged to collect them, e.g. to comply with retention periods of the tax office. It is based on Article 6 (1b) and (c) GDPR. This data is stored on the servers of wibas GmbH and can only be accessed by authorized persons. The data will be deleted as soon as it is no longer required for the aforementioned purposes. Any further processing of your personal data will only take place with your consent (voluntary).

We may use the third-party programs "Microsoft Teams" and "Miro" to conduct the events.

Data protection rights of the customer and contact details
